About this Form

This form is used to make an application to the District Court to vary or discharge an order in relation to arrangements for children. These are orders such as an order for guardianship, custody, access, or another matter affecting the welfare of a child.

- **Guardianship** is a person's legal responsibility to make decisions and perform duties regarding a child's upbringing.
- **Custody** means the day-to-day care and home life of a child under the age of 18.
- **Access** is the legal right of a child and an adult to have contact with one another where they do not live together.
